Letters of Demand

Letters of demand are charged out as follows:-

- Non-regular clients who are instructing us for the first time are charged \$200.00 for their first matter and \$100.00 for any further matters. Follow-up demands on a matter are charged at the rate of \$50.00 each.
- Regular clients are charged a negotiated fee (starting at \$75.00 per initial demand), which will vary down according to their volume. Follow-up demands are charged at the rate of \$ 20.00 each.

These are "all inclusive" fees which includes preparation of the demand and any subsequent telephone calls/correspondence regarding the matter up to the point where the matter is either finalised or alternatively, referred to legal. This is the only charge pre-legal, except for searches which may be requested or necessary. There are no commissions with respect to any monies recovered, at this or any other point.

Proceedings to Judgment

If we are instructed to issue legal proceedings (whether subsequent to or in lieu of a demand), these are charged out in accordance with the relevant Court Scale. Most credit applications nowadays incorporate provisions, allowing for costs incurred by you in relation to recovery proceedings, to be claimed back from the debtor. The advantage of our charging you any Court Scale fees, is that these costs will form part of the judgment and are added to each process as we go along. This will avoid separate costs arguments at a later stage.

These fees are with respect to undefended matters. If matters become defended, we will advise you separately.

Magistrates' Court

In South Australia, claims for debts up to \$100,000.00 are issued from the Magistrates' Court. Clients are charged in accordance with the Magistrates' Court Scale of fees and costs and Schedule 1 incorporates the same.

Fees for the service of Magistrates' Court Claim (Summons) will be charged to you as set out in Schedule 1.

Business name and/or company search fees are allowed to be added to the amount claimed from the debtor in the Magistrates' Court Claim.

District Court

In South Australia, claims for debts over \$100,000.00 are issued out of the District Court. Schedule 2 sets out the District Court Scale fees and costs in relation to the issue of District Court Summonses and proceedings to judgment thereafter. Process server fees and search fees are not able to be added to the amount claimed from the debtor.

Winding up Summonses

In the event that winding up proceedings are contemplated, these are charged in accordance with Schedule 3. Again these fees and costs are charged in accordance with the Federal Court Scale and can be claimed back from the debtor on payment out.

Bankruptcy

Costs in relation to Federal Circuit Court proceedings (Bankruptcy) are charged in accordance with the relevant Court Scale. Schedule 4 sets these out and again, these are the fees and costs which can be claimed back from the debtor on a request for payment out.

GST

All fees quoted are GST exclusive. GST is added at the time accounts are rendered. Court filing fees are exempt from GST and this will be clearly shown on any accounts that we forward to you. GST charged to you is not claimable from debtors.

- Magistrates' Court Claim fees & costs do not include any company/business name search fees &/or service/bailiff fees which may be necessary depending upon the type of &/or location of debtor(s)
- For a debt that is in excess of \$12,000.00 under the Court Rules we must issue a P1 Final Notice. The Magistrates' Court P1 Final Notice fee is \$26.00 Our fees are \$200.00 (plus GST).
- The service fee allowed by the Court is \$46.00 per person for personal service by a Court Sheriff. Higher service fees may be charged to clients in the event that the debtor or debtors is a natural person and we are billed a higher fee by our process servers above that the Court allows. Postal and email service will be charged at the rate of \$55.00 per person.
- The Court fee for the issue of a Magistrates' Court Claim where the debt is in excess of \$12,000.00 is separated into three (3) tiers. The higher fee applies to all corporations with more than 20 full-time equivalent employees.
- The Court fees quoted for Warrants of Sale and Warrants of Commitment will be higher in the event that there are multiple debtors at different addresses. In such cases, the Court fees will be \$ 174.50 per address.

Charging Orders

Where judgment debt is up to \$10,000.00 - \$240.00 legal fees + \$192.00 Lands Titles Office registration fees

Where judgment debt exceeds \$10,000.00 - \$500.00 legal fees + \$192.00 Lands Titles Office registration fees
